

## Selected News from our Regional VPs



In this issue, we bring you some new and noteworthy items from our **VP Asia**, Lihua Yang, and **VP Western Europe**, Eva Thomann.

### Publications:

In line with our next year's conference, we are happy to draw your attention to a study that reveals role conflicts, ambiguities, and tensions in the interaction between scientific advisors and policy-makers in the context of the COVID-19 crisis:

In his publication in Chinese language, Lihua Yang argues that in our attempts to research contemporary public administration, public management, and governance in a broader sense, it is necessary to develop a historical research path and develop a systematic science of historical public administration:

### Projects:

The Zurich University of Applied Sciences (ZHAW), University of Potsdam, the Vienna University of Economics and Business (WU Wien) launch a joint research project on **“Digital Transformation at the Local Tier of Government in Europe: Dynamics and Effects from a Cross-Countries and Over-Time Comparative Perspective (DIGILOG)”**. This collaborative research project systematically analyzes the state of implementation and the effects of the digital transformation at the local government level in Europe in a cross-countries and over-time comparative manner. It focusses on the dynamics (scale and pace) of the digital transformation and its intended and unintended effects. The € 1.1 mio. Project will take the form of a regular and automated quantitative survey of all local authorities in 47 European countries (members of the Council of Europe), based on web crawling and machine learning techniques, and case studies in selected European countries.

The project is jointly led by [Prof. Dr. Sabine Kuhlmann](#) and [Prof. Dr. Isabella Proeller](#) (University of Potsdam), [Prof. Dr. Reto Steiner](#) (ZHAW Zurich University of Applied Sciences) and [Prof. Dr. Renate Meyer](#) (Vienna University of Economics and Business). The project runs from 2022 to 2025 and is funded by the [Swiss National Science Foundation](#) (SNSF) and the [German Research Foundation](#) (DFG). ## Awards and Prizes



The calls for the **IRSPM Routledge lifetime achievement award 2023** and **IRSPM O'Leary prize 2023** are open until **16 January 2023**.

The **Rosemary O'Leary Prize** for Scholarship on **Women in Public Administration** was first awarded in 2019, and was established to recognise excellent scholarship on women in public administration, broadly defined. It is named after Professor Rosemary O'Leary who is an outstanding public management scholar and a previous IRSPM Routledge lifetime achievement award winner.

The **Routledge lifetime achievement award** is presented to an outstanding scholar who has made sustained contributions to public management research over a significant period of time.
